

HOW TO ENTER

Beginning at 12:00am Eastern Time (“ET”) on **February 28, 2011**, entrants can enter the “**HCC March Madness 2011**” (the “Contest”) by on-line entry form. All entries must include all information requested on the on-line form. Incomplete, late or duplicate entries will be disqualified. [Any use of automated devices is prohibited. Only 1 entry per person.](#)

CONTEST CLOSING DATE: To be eligible to win the Contest, complete eligible entries must be received no later than 11:59pm ET on **April 22, 2011** (the “Contest Closing Date”).

THE DRAW
